(D1) The Officers of the Club shall be the President, Chairperson, Club Captain, Vice-Captain, Immediate Past Captain, Lady Captain, Lady Vice-Captain, Seniors' Captain, Club Secretary, Treasurer, Handicap Secretary, Competition Secretary, Junior's Organiser, Rules Secretary, Team Captain and Greens Committee Representative. The Membership and Minutes Secretaries will also be Officers of the Club, but will be responsible to the Club Secretary.

Proposed change

(D1) The Officers of the Club shall be the President, Club Captain, Vice-Captain, Immediate Past Captain, Lady Captain, Lady Vice-Captain, Seniors' Captain, Club Secretary, Treasurer, Handicap Secretary, Competition Secretary, Junior's Organiser, Rules Secretary, Team Captain and Greens Committee Representative. The Minutes Secretary will also be an Officer of the Club, but will be responsible to the Club Secretary.

(G4) General Meetings shall be chaired by The Club Chairperson or in his/her absence the Club Captain or in his absence the Vice Captain or in his absence a person elected by those present and eligible to vote at the start of the meetings. In the case of an AGM the outgoing Chairperson, Captain and Vice-Captain shall retain their positions until the hand-over at that meeting.

Proposed change

(G4) General Meetings shall be chaired by The Club Captain or in his absence the Vice Captain or in his absence a person elected by those present and eligible to vote at the start of the meetings. In the case of an AGM the outgoing Captain and Vice-Captain shall retain their positions until the hand-over at that meeting.

Subscriptions

Fees are due to be paid within one calendar month from the first day of January of each year.

Proposed change

Fees are due to be paid within one calendar month from the first day of January of each year, thereby granting one month's grace to existing members of the club.

Committee and General Meetings

Management of the Club shall be the sole responsibility of the elected Committee. That Committee shall consist of The Chairperson, Captain, Vice-Captain, Immediate Past Captain, Lady Captain, Lady Vice-Captain, Senior's Captain, The Club Secretary, The Treasurer, The Competition Secretary, The Team Captain, The Handicap Secretary, The Rules Secretary, The Junior's Organizer and The Greens Committee Representative. , The Membership Secretary and the Minutes Secretary will attend committee meetings, but will not be entitled to vote.

Proposed change

Management of the Club shall be the sole responsibility of the elected Committee. That Committee shall consist of The Captain, Vice-Captain, Immediate Past Captain, Lady Captain, Lady Vice-Captain, Senior's Captain, The Club Secretary, The Treasurer, The Competition Secretary, The Membership Secretary, The Team Captain, The Handicap Secretary, The Rules Secretary, The Junior's Organizer and The Greens Committee Representative. The Minutes Secretary will attend committee meetings, but will not be entitled to vote.

Duties of Officers

THE CHAIRPERSON

The Chairperson shall: chair all Committee and General meetings, or in his/her absence Committee and General meetings will be chaired by the Club Captain, or in his absence The Vice-Captain shall take the chair, or in his absence a person elected by those present and eligible to vote at the start of the meetings.

Proposal is to remove this post from the committee and replace with:

THE CAPTAIN

The Captain shall: chair all Committee and General meetings, or in his/her absence Committee and General meetings will be chaired by the Vice-Captain, or in his absence a person elected by those present and eligible to vote at the start of the meetings.
